NOTE FOR DESIGNERS: This template is scaled at 100%, and represents a possible label shape and size that could fit this item. We highly recommend you order a sample, print your artwork to scale, cut it out, and confirm proper fit prior to submitting your artwork for print. The **bleed line** allows the background artwork to extend beyond the trim line. This ensures a clean print all the way to the edge when the label is trimmed. The trim line is where the label is cut. This is the maximum recommended label size. All critical text and design elements should remain within the design clearance line.
